Decided

Article 1: Membership (According to Article 10 of Statute of the Association)

There are 2 categories of the association membership:

- active members are all water service providers, either individuals or legal entities who receive the license from the Ministry of Industry and Handicraft.
- ◆ associate members are individuals or legal entities who are involved or interested in field of water supply in Cambodia including material and chemical supplier, bank, NGO, and other business partners.

Article 2: Membership Registration (According to Article 10 and 11 of Statute of the Association)

Registration to be active members is opened to all individuals or legal entities who are water service providers in Cambodia and received the license from the Ministry of Industry and Handicraft.

Registration to be associate members is opened to all individuals or legal entities who are involved or interested in field of water supply in Cambodia including material and chemical supplier, bank, NGO, and other business partners.

The association encourages students or retired staff to register to be associate members by discount annual membership fee 80% for students and 100% for retired staff.

To be a member of the association, individuals or legal entities must meet the following conditions:

For active members:

- 1. individuals or legal entities who are water service providers in Cambodia and received the license from the Ministry of Industry and Handicraft;
- 2. completed and apply for active members, and comes with license; and
- 3. have paid for membership fee for at least 6 months.

For associate members:

- 1. individuals or legal entities who are involved in field of water supply in Cambodia;
- 2. completed and apply for associate members, and comes with photo 4x6 (1 piece) (and copy of institution establishment for legal entities);
- 3. were permitted to be member from association; and
- 4. have paid for membership fee for at least 6 months.

Article 3: Right of Member (According to Article 10 of Statute of the Association)

Active members can vote while the associate members cannot, but he/she can join and express his/her opinion in the association's general and extraordinary general assembly.

Article 4: Membership Fee

All members of the association have to pay for membership fee in every 6 months or annual to support the work of the association. Membership fees are defined by type and size of the water supply business as following:

- 1. individual associate member has to pay annually at least USD 50 (fifty US dollars);
- 2. Khmer legal entity associate member has to pay annually at least USD 200 (two hundred US dollars);
- 3. foreign legal entity associate member has to pay annually at least USD 300 (three hundred US dollars);
- 4. active member of micro water service provider, less than or equal to 750 connections, has to pay annually at least USD 130 (one hundred and thirty US dollars);
- 5. active member of small water service provider, from 751 to 1,500 connections, has to pay annually at least USD 180 (one hundred and eighty US dollars);
- 6. active member of medium water service provider, from 1501 to 3,000 connections, has to pay annually at least USD 300 (three hundred US dollars); and
- 7. active member of large water service provider, more than 3,000 connections, has to pay annually at least USD 500 (five hundred US dollars).

Members who pay a minimum annual amount as defined above will be able to get one more representative to get benefit of the association membership for payment of USD 100 (one hundred US dollars) plus the minimum payment.

Frist time payment of membership fee for new members will be determined depending members as following:

- first quarter (from January 1 to March 31) will be charged 100% of the total payment;
- second quarter (from April 1 to June 30) will be charged 75% of the total payment;
- third quarter (from July 1 to September 30) will be charged 50% of the total payment; and
- fourth quarter (from October 1 to December 31) will be charged 25% of the total payment.

Article 5: Benefit of Member of the Association

Article 6: Loss of Membership (According to Article 13 of Statute of the Association)

Members of members may lose their membership in any cases of the following:

- resigning in writing and inform at least 1 week before9
- active members who lost their water supply business license issued by Ministry of Industry and Handcraft
- convicted of any crime imprisonment

^{**} number of representatives can be increased one person by paying USD 100 plus the minimum payment.

• decision to withdraw from membership of Board of Directors' meeting by 50% plus 1 if a member violated the regulation and the decision of the association which cause damage to the interests of the entire association.

Article 7: Amendment

This membership policy is a living document; when the association grows and water supply sector changes, some articles of this policy can be amended to make this policy remains effectiveness in helping the performance of the association.

The association has to review the policy at least once in two years and make any adjustments in case of necessary. Any changes must be made in writing and approved by the Board of Directors of the association.

Article 8: Validation

All staffs and members of the association are required to comply with this membership policy from the date of signature of the president of Board of Directors.
