- I am committed to get a 20-year permit from MISITI for my proposed service area (if not licensed).
- The service coverage area of my proposed site (uncovered area) has a number of households not less than **2,000** and not more than **10,000**.
- I can prove my business experience in at least one of the following:
  - I have at least one year of experience as the owner of a water service company; or
  - I have at least two years of experience in a water business or other related business (but not including a small retail store); or
  - I can provide a letter of support from friends, colleagues or relatives who are owners or have experience in the water business.
- I can prove my technical experience in at least one of the following:
  - My experience is in operating a water business, or
  - I have staffs in the company who are experienced in the water business, or
  - I have a plan to train and develop the skills of myself and my staffs.
- I have a good collaboration with and support from local authorities and water consumers.
- One of the following statements applies the water source of my proposed service area.
  - The water source(s) could supply water to all households all year round; or
  - The project requires an addition pond with estimated not more than 3 months of storage in order to supply to all households all year round.
- I agree that CAP-RED's hydrological calculation will determine whether my propose site is qualified for grant support.
- I commit to embracing gender equality, disability, and social inclusion (GEDSI) in my employment process and business management. I am willing to collaborate with CAP-RED to assess improvement opportunities and provide my workers and staff with GEDSI-related training.
